#### The Prez Sez-Medical Reform and the Future of LSA

One of the biggest things to happen in aviation this year was the signing of the FAA reauthorization bill on July 15<sup>th</sup>. After battles in Congress that included a proposal for the privatization of the ATC system, the much-awaited medical reform is now the law, almost. I say almost because nothing changes until the FAA comes up with their implementation plan, which will take some time. If they don't do it within a year, the law takes effect anyway.

In the meantime, if your medical is expiring soon, you'll need to get another one.

While at first glance, the new law seems to be an expansion of the current rules for flying Light Sport, there's one important difference. Under LSA rules, if you have a driver's license, you don't need to have ever received a FAA medical. To fly under the new regulations, you have to have received a medical at some point, as long as 10 years ago. If you have a condition that prevents you from getting a medical at all, the new rules don't apply to you.

It will be interesting to see how many people who let their medicals lapse in the last few years and either gave up flying or turned to LSA's will return to flying bigger planes. I suspect at least one of our members will do this at least in his role as a CFI.

One thing that no one seems to be talking about is how this will affect the LSA industry. With a few notable exceptions, manufacturers have been struggling to stay in business. I suspect their numbers will dwindle even more. I don't think there are any statistics, but it seems that many pilots who used to fly 172's, Cherokees, etc. and had concerns about passing their physicals, decided to let their medicals lapse and bought LSA qualified airplanes, either new or used. Used light sports are affordable for many people. New ones are out of reach for many.

When the sport pilot rules were adopted, the promise of low-cost flying quickly flew out the window for many. Sure, you only need about half of the hours you do for a private license and fuel burns are a lot lower. But that's offset by the cost of a new LSA airplane, \$100,000 plus. Most flight schools also took a pass. For the price of a new light sport, you can have 2 or 3 older 4-place trainers on the line, which will probably rent for less.

It will be interesting to see what happens.
